In consideration of twenty five dollars the receipt whereof is hereby acknowledged Mary A Calderwood grants to Northwestern Electric company a perpetual right of way in and over the following described real property situated in the county of Skamania state of Washington : That part of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of section 29 T 3 N R 8 E.W.M. lying east of the land of Grimes N. Calderwood shown in record Book I of deeds page 175 records of said County and state Also all interest I may acquire by inheritance or otherwise from David E. Calderwood my husband; and will warrant and defend the grantor against all lawful claims whatsoever, for the purpose of erecting maintaining and operating two pole or tower lines for the transmission of electric current, together with the right to cut such trees and brush as may be necessary in constructing maintaining and protecting such lines from damage. The said pole lines not to exceed 50 feet apart when constructed.

Hadley to N.W. Electric Co.

In consideration of One dollar the receipt whereof is hereby acknowledged W.O. Hadley & Minnie E. Hadley his wife, S.S. Hayes and Ella E. Hayes his wife grant to Northwestern Electric company a perpetual right of way in and over the following described real property situated in the County of Skamania State of Washington to-wit:

Lots one (1) and five (5) in Section thirty-six (36) Township three (3) North of Range eight (8) East of Willamette Meridian, and the West 660 feet in width off the west end of the James Finley D.L.C. in said section thirty six (36) being known as the west 40 acres of said claim, for the purpose of erecting maintaining and operating two pole or tower lines for the transmission of Electric Current, together with the right to cut such trees and brush as may be necessary for the construction maintaining and protecting such lines from damage. The South transmission line has been surveyed and staked out across aforesaid land and the last survey has been adopted by the company and enters the west line of said Lot one (1) 220 feet north of the center line of the Spokane Portland & Seattle Railroad, running thence easterly 1080 feet to a point 210 feet north of the said center line of the railroad track, thence easterly 814 feet to a point 160 feet north of the center of said railroad track, thence easterly to a point in the east line of said forty acre tract in said D.L.C. 300 feet north of the center line of said railroad. The second line shall be constructed within fifty feet of the aforesaid line and north thereof.
