In consideration of one dollar the receipt whereof is hereby acknowledged J.P.Grenia and Ella M Grenia his wife grant to the Northwestern Electric Company a perpetual right of way in and over the following described real property to-wit:

Lot six (6) and the southwest quarter of the Southeast quarter, also the Southeast quarter of the southwest quarter of section 19 Township two North of Range 7 East of W.M., for the purpose of erecting maintaining and operating thereon two pole or tower lines for the transmission of electric current, together with the right to cut such trees and brush as may be necessary in constructing maintaining and protecting such lines from damage; one line is surveyed and staked out across the land and begins in the east line of said lot 6 1966 feet northerly from the intersection of the west line of the S.M.Hamilton Donation Land claim with the south line of said section 19, measured along said westerly line of said D.L.C., thence in a straight line to a point in the west line of said SE 1/4 of SW 1/4 of said Sec.19- 120 feet north of center of the railroad track of the S.P.& S Ry Co. which point is in the south side of the new road where it crosses said line; the second line shall be constructed parallel with said staked line and not to exceed 50 feet from it and in a northerly direction subject to state road right of way.
