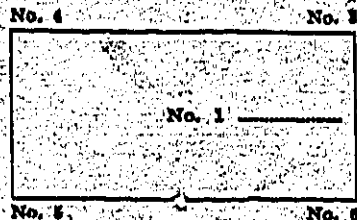

has located and do hereby locate 1500' linear feet in length, and 600' feet in width on the Lode Vein

lode, vein, ledge or deposit (or placer ground), situated in above State, County or Mining District, and further described as follows: Commencing at a post marked No. 1 at the Discovery Shaft (cut or tunnel), from thence
