

Now, therefore, if the said mortgagors shall pay said notes together with the interest thereon according to the true intent and tenor thereof, then this obligation to be void otherwise to remain in full force and effect. It is further covenanted and stipulated in case of default in the payment of any of said principal sum or the interest thereon this mortgage may be foreclosed and said property sold in the manner provided by law and any sum found due for taxes, insurance, or other outlay for the protection of said property together with any amount found due for principal or interest be paid from the proceeds of said sale. In case of any suit in foreclosure being brought upon this mortgage there shall be allowed an attorney's fee to plaintiff's attorney in such sum as the court shall adjudge reasonable. It is specially stipulated and agreed that a deficiency judgment may be taken in any suit in foreclosure of this mortgage.
