I, the undersigned, being the owner of the property herein described, do, in consideration of Three hundred & seventy five Dollars the benefits and advantages to accrue to her by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit: On the survey of the State Road across the West ½ of the NE¼ and lots 1 & 2 of Sec.6 twp.1 N.R.6 East W.M. and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a State Road.
