WAIVER OF CLAIM FOR DAMAGES AND CONSENT TO
LOCATE ROAD

I, the undersigned, being the Owner of the property herein described, do, in consideration of the benefits and advantages to accrue to me by the location and establishment of the above proposed State Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit: The W $\frac{1}{2}$ SW $\frac{1}{4}$ S 34 T.2 N., R.6 E.W.M. and the NW $\frac{1}{4}$ NW $\frac{1}{4}$ S 4, T 1 N.R 6 E. W.M. lying North of the Present right of way of the Portland & Seattle R.R. Co. It being understood that by reason of such location the present County Road from the E line of said W $\frac{1}{2}$ to the W line of said NW $\frac{1}{4}$ is to be abandoned and is to revert to me where it is on my land, and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a State Road.

WAIVER OF CLAIM FOR DAMAGES AND CONSENT TO
LOCATE ROAD

We, the undersigned, being the owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed State Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit: NE $\frac{1}{4}$ SW $\frac{1}{4}$ S 34 Tp.2 N. R 6 E.W.M. lying north of the P & S. R.R. Co's right of way. It being understood that the present Co.Road is to be abandoned and revert to us where on our land - 50 ft is to be reserved between the P & S Co's right of way and the S.R.Survey from the east line to Duncan Creek and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey lay out and establish said Road as proposed, and to perpetually maintain the same as a State Road.
