

Button to Wells.

KNOW ALL MEN BY THESE PRESENTS, That Elizabeth A. Button, widow of Henry H. Button, deceased, and Charles P. Button and Henry H. Button, his sons, and Lizzie E. Button, wife of said Henry H. Button, all of Milwaukee, parties of the first part, in consideration of the known purpose of said Henry H. Button, deceased, in his lifetime to make such a conveyance and of the sum of One Dollar to them duly paid, do hereby remise, release and quitclaim unto Louisa M. Wells, daughter of said Henry H. Button, deceased, of the same place, party of the second part, and to her heirs and assigns, the following described real estate, situated in the county of Milwaukee, State of Wisconsin, to wit:

That piece or parcel of land forming a part of Lot numbered Four (4) in Block numbered One hundred and ninety six (196) of Rogers Addition in the First Ward of the city of Milwaukee, Beginning on the Westerly line of Franklin Street at the Northeasterly corner of said Lot numbered Four (4) running thence Westerly and parallel with the Northerly line of said lot one hundred and thirty five and 50/100 ($135\frac{1}{2}$) feet to a point; thence southerly and parallel with the Westerly line of Franklin Street sixty (60) feet to a point; thence Easterly and parallel with the Northerly line of said Lot One hundred and thirty five and 50/100 ($135\frac{1}{2}$) feet to a point; thence Northerly on the Westerly line of Franklin Street sixty (60) feet to the place of beginning.

TO HAVE AND TO HOLD the same, together with all and singular the appurtenances and privileges thereunto belonging, or in anywise thereunto appertaining, and all the estate, right, title, interest and claim whatsoever of the said parties of the first part, either in law or equity, either in possession or expectancy, to the only proper use, benefit and behoof of the said party of the second part, her heirs and assigns forever.
