

intersects the dividing line between lots three hundred four (304) and three hundred five (305) in Fruit Home Colony in Section three (3), Township three (3) north, Range Ten (10) east of the Willamette Meridian, in Klickitat County, State of Washington, according to the duly recorded plat thereof; thence northerly along the line one hundred (100) feet easterly from and parallel with said ordinary high water line to a point south fifty-six (56) degrees and thirty (30) minutes west five hundred thirty-six (536) feet more or less from the quarter corner between Section two (2) and three (3) in said township and range; thence north twenty-nine (29) degrees thirty (30) minutes east two hundred eight (208) feet; thence north fifteen (15) minutes east four hundred seventy-eight (478) feet; thence north fifty-two (52) degrees and fifteen (15) minutes east to the dividing line between Lots three hundred six (306) and three hundred five and one-half (305½) in said Fruit Home Colony; thence following the last said dividing line in a general northwesterly direction to intersection with the center line of the White Salmon River, thence southerly following said center line of the White Salmon River to intersection with the dividing line, produced, between Lots three hundred four (304) and three hundred five (305) in said Fruit Home Colony; thence southeasterly along the last said dividing line to the point of beginning, containing five and seventy-two hundredths (5.72) acres more or less, together with all riparian rights and the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining; also all that part of Lot two hundred fourteen (214) of said Fruit Home Colony, according to the duly recorded plat thereof, which lies northerly of a line running parallel with and one hundred (100) feet southerly from the ordinary high water line of the White Salmon River on the southerly shore thereof and situated in Klickitat County, State of Washington, together with all riparian rights and the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining. And also

A strip of land of varying width across the northeast quarter of the southeast quarter of Section Three, township three north range ten east of the Willamette Meridian, bounded on the northwesterly side by a line one hundred feet from ordinary high water in the White Salmon river, and on the southeasterly side by the center line of the said White Salmon River, containing four and nine hundredths (4.09) acres, more or less. And also a tract described as follows:

Beginning at the southeast corner of the west half of the southeast quarter of the Northeast quarter of section three, township three north range ten east Willamette Meridian; thence west along the south line of said west half ninety feet more or less to a point one hundred feet from ordinary high water in White Salmon River; thence in a northerly direction one hundred feet from and parallel to the said ordinary high water line seven hundred feet more or less, to a point on the east line of said west one-half of the southeast quarter of the northeast quarter of section three; thence south along said east line of west one-half, to the line between Lots 305½ and 306, Fruit Home Colony, produced westerly; thence easterly along said dividing line between Lots 305½ and 306, Fruit Home Colony, to the center of White Salmon River; thence following along the center of the White Salmon River to the south line of the southeast quarter of the northeast quarter of said section three; thence along the south line of the southeast quarter of the northeast quarter of said section three to the point of beginning, containing one and ninety one-hundredths (1.90) acres, more or less. And also a tract described as follows:

Beginning at the southwest corner of the north half of the northeast quarter of the southeast quarter of section three, township three north, range ten east Willamette Meridian, south sixty-two degrees twenty-three minutes west, fourteen hundred fifty-two and seven-tenths feet (1457.7) from the quarter-corner between sections two and three, said township and range;
