Also the plan of construction is such that no wires or cables on said land shall be placed below the level of the railroad track, which is Southerly of said poles or towers.

And the Northwestern Electric Company hereby accepts said right-of-way subject to all damage that may occur to the poles or towers or transmission lines by the use of the premises upon which they are located, by the Wind River Lumber Company and its assigns in using said premises for driving, booming, rafting, sacking or the storage of logs or other timber products or in the course of business of said Wind River Lumber Company, and also subject to any damage to the said erections, constructions, or lines upon said premises, caused, suffered or done by the Skamania Boom Company or assigns in its driving, booming or flooding operations or by it through any of its operations in the conduct of its business, all damages incident to said operations being higreby waived by acceptance of said right-of-way.
