WAIVER OF CLAIM FOR DAMAGES
AND CONSENT TO LOCATE ROAD

We, the undersigned, being the Owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed State Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit: SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, and Lots 6 and 9 Sec.19, Tp.2 N.R.7 E., W.M. lying north of the P & S R.R. Co's right of way. The present Co. road, where not used by the State road to be abandoned and to revert to us where it is on our land and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a State Road.

WAIVER OF CLAIM FOR DAMAGES AND CONSENT
TO LOCATE ROAD

In the Matter of the Petition of
State Road No.8 et al. for a Road to be
known as the Lyle Washougal State Road.

We, the undersigned, being the owners of the property herein described, do, in consideration of \$50. to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit: SW $\frac{1}{4}$ of SW $\frac{1}{4}$ Sec 22 T 3-8 E W.M. in Skamania County, State of Washington and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.

The relinquishment herein mentioned is given and granted to Skamania County Washington subject to the right of the grantors to cut, use and dispose of all the growing timber on said right of way, and it is hereby agreed that the grantors shall have five years to cut and remove said timber, provided however said timber that is in the way of construction of said
