This Indenture Witnesseth that Ignaz Wachter and Helena Wachter husband and wife, parties of the first part for and in consideration of the sum of four thousand five hundred dollars (\$4500) in lawful money of the United States to them in hand paid by E.C. Hove, the party of the second part have granted bargained and sold and by these presents do grant bargain sell and convey unto the said party of the second part his heirs and assigns all the following described real property lying and being in the County of Skania State of Washington to-wit:

The East half of the East half of the Northwest quarter of Section thirty six (36) Township three (3) North of Range seven (7) East of Willamette Meridian containing 40 acres; also that certain parcel of land described in a deed from Caspar Gropper to Ignaz Wachter recorded on page 625 in Book H of deeds records of Skamania County Washington as follows: Beginning at a point 31.70 chains east of the $\frac{1}{4}$ section corner between sections 35 and 36 Township 3 North of range 7 East of W.M. where a certain road intersects the line between said $\frac{1}{4}$ corner and center of section 36, thence along the center of said road S 66 Deg.
