THIS INDENTURE, Made this 6th day of August in the Year of our Lord One Thousand Nine Hundred and Nineteen BETWEEN L. A. StMartin and Celina A. StMartin, husband and wife, parties of the first part, and Neva Wood Flesher party of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of One Thousand and Fifty and no/100 (\$1050.00) Dollars, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN, SELL CONVEY and WARRANT unto the said party of the second part, and to her heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

Beginning at a point 605 feet West and 219 feet South of the Northeast corner of the Northwest quarter of the Northeast quarter of Section 29, Township Three (3) North of Range Eight (8) East of the Willamette Meridian, thence South 200 feet, thence West 200 feet, thence North 290 feet, thence East 200 feet, thence South 90 feet to the place of beginning.
