M. , together with all its right, title and interest in and to that certain right of way to and from said fish wheel as per that certain lease dated the 8th day of August 1913, between said The Diamond L. Lumber Company and Erick Enquist, which lease was on Sept. 2nd, 1913, assigned to J. H.
