KNOW ALL MEN BY THESE PRESENTS: That I, Robert Krims, the party of the first part, for and in consideration of the sum of One (\$1.00) Dollar, and other valuable considerations, to me in hand paid by J. F. Duffy, the party of the second part, the receipt of which is hereby acknowledged, have GRANTED, BARGAINED, SOLD, ASSIGNED, TRANSFERES, and SET OVER, and by these presents do Grant, Bargain, Sell, Assign, Transfer and Set Over unto the said party of the second part a certain Indenture of Mortgage, bearing date the 31st day of May, 1917, made and executed by Oscar F. Felton and Mary Felton, husband and wife, to Charles T. Early, to secure the payment of the sum of Two Thousand Fifty-six (\$2056.00) Dollars, upon
