THIS INDENTURE, Made this 18th day of September, 1919, between Lena Hapgood and F. H. Hapgood, her husband, of Stevenson, Skamania County, Washington, parties if the first part, and A. A. Disbrow, of same place, party of the second part,

WITNESSETH, That the said parties of the first part for and in consideration of the sum of Three Hundred (\$300.00) Dollars, lawful money of the United States, to them in hand paid by the said party of the second part, receipt whereof is hereby acknowledged, do be these presents, GRANT, BARGAIN, SELL, CONVEY and WARRANT unto the said party of the second part, and to his heirs and assigns, the following described tracts and parcels of land, lying and being in the County of Skamania, State of Washington, and particularly bounded and described as follows, to-wit:

Two contiguous and adjoining tracts of land described by meets and bounds as follows:

(1st) Beginning at the Northeast corner of Section Two (2), Township Two (2) North of Range Seven (7) East of the Willamette Meridian; running thence due South to the North line of the Baughman Donation Land Claim; thence West 330 feet along the North line of said Donation Land Claim, thence due North to the North line of said Section Two (2) Township Two (2) North of Range Seven (7) East of the Willamette Meridian; thence East Three Hundred Thirty (330) feet to the point of beginning.
