KNOW ALL MEN BY THESE PRESENTS, That the COLUMBIA CONTRACT COMPANY, a corporation organized and existing under the laws of the State of Oregon, and CHARLES E. LADD and SARAH H. LADD, his wife, for and in consideration of One Dollar, receipt whereof is hereby acknowledged, have granted and by these presents do grant unto NORTHWESTERN ELECTRIC COMPANY, a corporation organized and existing under the laws of the State of Washington, a revocable license to build and maintain one pole or tower line for the transmission of electricity across that part of the lands of the grantors in Section twenty-five (25), Township two (2) North, Range six (6) East of the Willamette Meridian, in Skamania County, State of Washington, which lies South of the right of way of the Spokane Portland & Seattle Railway Company as now located.
