KNOW ALL MEN BY THESE PRESENTS, That Louis Thun of the County of Skamania, State of Washington, being of lawful age, in the consideration of one dollar and other value Dollars, to him paid by Lizzie G. Packard, Schuyler Clark, F.S. Forest, P.I. Packard and W.H. Morrow of Skamania County in the State of Washington hereby grant, bargain, sell and convey unto said Lizzie G. Packard, Schuyler Clark, F.S. Forest, P.I. Packard and W.H. Morrow, and unto their heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington.

To Lizzie G. Packard, Schuyler Clark, F.S. Forest, an undivided three-fifths (3/5) interest, and to P.I. Packard and W.H. Morrow-jointly-an undivided one-fifth (1/5) interest in a strip of land eight feet wide along the west side of the West half of the South half of the North half of the Northeast quarter of the Southeast quarter of Section fifteen (15) Township three (3) North of Range ten (10) East of Willamette Meridian, County and State aforesaid;

The said strip of land to be used as a road, and to be known as "Orchard Lane".
