

TRACT OR PARCEL OF LAND LYING AND BEING IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS, TO-WIT:

BEGINNING AT THE SOUTHWEST CORNER OF A TRACT OF LAND HERETOFORE SET APART OUT OF THE ESTATE OF WILLIAM HAFLEY, DECEASED, FOR CORNELIUS HAFLEY AND LATER DEEDED BY HIM TO JOHN T.
