CASCADE LAND AND INV.CO TO N.W.ELECTRIC CO.

KNOW ALL MEN BY THESE PRESENT, That the Cascades Land and Investment Company, a corporation under the laws of the State of Washington in consideration of One (1.00) dollar paid by the Northwestern Electric Company, does hereby grant, bargain, warrant and convey unto the said Northwestern Electric Company a perpetual right-of-way in and over the following described real property, situated in the County of Skamania, State of Washington to-wit:

The Bush Donation Land Claim and lots 5 and 6 in section 10, township 2 North, Range 7 East of the Willamette Meridian, also the B.B. Bishop Donation Land Claim in sections 16 and 17 in said township and range.

For the purpose of erecting and maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage. (Except the right of Four Lakes Lumber Company)

One line is surveyed and staked across said lands and enters the easterly line of the Bush Donation Land Claim about 150 feet southerly from the quarter corner between sections 10 and 11 in said township and range, and runs thence southwesterly in nearly a straight line to a point in the south line of section 10 about 965 feet west of the quarter corner between section 10 and 15,
