NELSON TO NORTHWESTERN ELECTRIC COMPANY

In consideration of One Dollar, the receipt whereof is hereby acknowledged, Eva V. Nelson and S. D. Nelson, her husband, grant to Northwestern Electric Company a perpetual right of way in and over the following described real property, situated in County of Skamania, State of Washington, to-wit: Lots Two (2) three (3) and four (4) and the N.E. 1/4 of the NW 1/4 also the North half of the NE 1/4 of section 35, in Township 2 N. Range 6 east of the Willamette Meridian. Excepting about five (5) acres more or less of the East end sold to Darr and Watson. Also excepting any land belonging to William Butler. for the purpose of erecting, maintaining and operating thereon, one pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage. The pole or tower line has been surveyed and runs in a straight line from the north side of the island on which William Butler resides, to the railroad right of way line on the land of Watson and Darr.

This deed is made to correct an error in the deed executed by the grantors on April 29, 1912, and recorded on June 4, 1912 in Book 10 of deeds, page 588 records of Skamania County, Washington.
