THE MORTGAGORS CHAS. O. WILLIAMS AND AMANDA E. WILLIAMS, HUSBAND AND WIFE OF SKAMANIA, COUNTY OF SKAMANIA, STATE OF WASHINGTON, MORTGAGE TO THE ADJUSTMENT BUREAU OF THE PORTLAND ASSOCIATION OF CREDIT MEN, AN OREGON CORPORATION OF PORTLAND IN THE STATE OF OREGON, TO SECURE THE PAYMENT OF SIXTEEN HUNDRED FIFTY-TWO & 18/100 DOLLARS LAWFUL MONEY OF THE UNITED STATES, TOGETHER WITH INTEREST THEREON AT THE RATE OF SEVEN PER CENT PER ANNUM FROM DATE UNTIL PAID, ACCORDING TO THE TERMS AND CONDITIONS OF ONE CERTAIN PROMISSORY NOTE BEARING EVEN DATE HEREWITH MADE BY CHAS. O. WILLIAMS AND AMANDA E. WILLIAMS, HUSBAND AND WIFE, AND PAYABLE IN FOUR EQUAL INSTALLMENTS OF FOUR HUNDRED THIRTEEN & 5/100 DOLLARS, PAYABLE IN SIX, TWELVE, EIGHTEEN AND TWENTY-FOUR MONTHS RESPECTIVELY FROM DATE TO THE ORDER OF SAID ADJUSTMENT BUREAU OF THE PORTLAND ASSOCIATION OF CREDIT MEN, THE FOLLOWING DESCRIBED REAL ESTATE, SITUATED IN SAID COUNTY OF SKAMANIA AND STATE OF WASHINGTON, TO-WIT:

COMMENCING AT THE CENTER OF SECTION THIRTY-FOUR (34) TOWNSHIP TWO (2) NORTH OF RANGE SIX (6) EAST OF THE WILLAMETTE MERIDIAN, AND RUNNING THENCE WEST SIX HUNDRED FORTY-TWO (642) FEET TO THE CENTER OF DUNCAN CREEK; THENCE FOLLOWING THE CENTER OF DUNCAN CREEK IN A SOUTHERLY DIRECTION ABOUT SIX HUNDRED (600) FEET TO THE STATE ROAD; THENCE ALONG THE STATE ROAD TO THE EAST LINE OF THE SOUTHWEST QUARTER (SW $\frac{1}{4}$ ) OF SAID SECTION THIRTY-FOUR (34); THENCE NORTH TO THE PLACE OF BEGINNING, CONTAINING 4.64 ACRES MORE OR LESS; EXCEPTING A CERTAIN TRACT OF LAND SOLD TO SYLVAN GRANGE No. 474, DESCRIBED AS FOLLOWS; COMMENCING AT THE CENTER OF SAID SECTION THIRTY-FOUR (34), THENCE SOUTH ONE HUNDRED FIFTY (150) FEET; THENCE WEST ONE HUNDRED FOUR AND 9/10 (104.9) FEET; THENCE NORTH ONE HUNDRED FIFTY (150) FEET; THENCE EAST ONE HUNDRED FOUR AND 9/10 (104.9) FEET TO PLACE OF BEGINNING.
