NOW THEREFORE, I, EDDY P. MICHELL, THE DULY ELECTED, QUALIFIED AND ACTING AUDITOR OF SKAMANIA COUNTY, STATE OF WASHINGTON, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY THE TERMS AND PROVISIONS OF THE DECREE OF THE SUPERIOR COURT OF THE STATE OF WASHINGTON FOR THE COUNTY OF SKAMANIA AS HEREINABOVE RECITED, DO HEREBY CERTIFY THAT THAT CERTAIN MORTGAGE, BEARING DATE FEBRUARY 5, 1915, MADE AND EXECUTED BY ROSA M. THOMAS AND EDWARD R. THOMAS, HER HUSBAND, PARTIES OF THE FIRST PART THEREIN, IN FAVOR OF NORA K. ROLFES, PARTY OF THE SECOND PART THEREIN, FOR THE SUM OF \$4,400.00 SECURED UPON THE FOLLOWING DESCRIBED LAND, TO-WIT:

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION TEN (10) IN TOWNSHIP THREE (3) NORTH OF RANGE NINE (9) EAST OF THE WILLAMETTE MERIDIAN; RUNNING THENCE WEST ALONG THE FORTY ACRE LINE, FORTY (40) RODS; THENCE SOUTH, PARALLEL WITH THE EAST LINE OF SAID SECTION TEN (10) SIXTY (60) RODS; THENCE EAST PARALLEL WITH SOUTH LINE OF SAID SECTION FORTY (40) RODS TO THE SECTION LINE, THENCE NORTH ALONG THE SECTION LINE SIXTY (60) RODS TO THE PLACE OF BEGINNING, CONTAINING FIFTEEN (15) ACRES, EXCEPTING THEREFROM A STRIP OF GROUND TWENTY (20) FEET WIDE RUNNING EAST AND WEST ALONG THE NORTH LINE AND SIDE OF THE ABOVE DESCRIBED LAND FOR A ROAD RIGHT OF WAY.
