## DODGE TO J.K.LUMBER COMPANY.

THIS INDENTURE, Made this 3rd day of February, in the year of our Lord one thousand nine hundred and thirteen, between E.H.Dodge and Aida M.Dodge, his wife, of the County of Multnomah and State of Oregon parties of the first part, and J.K.Lumber Company, a corporation, of the County of Skamania and State of Washington, party of the second part.

Witnesseth, That the said parties of the first part, in consideration of the sum of One Dollar to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do hereby Grant, Bargain, Sell and Convey unto the said party of the second part, its successors and assigns forever, all the timber lying, standing or being upon all that tract or parcel of land lying and being in the County of Skamania and State of Washington, described as follows, to-wit: All of Lots numbered one (1) and two (2) and the South half of the Northeast quarter (S½ of NE½) of Section one (1), Township two (2) North, Range six (6) East of the Willamette Meridian, containing 160.40 acres. together with the right to enter upon said land and cut and remove therefrom at any time within twenty-five years from April 1903 the timber herein conveyed, hereby granting the right to cut such other timber and make such other alterations on said land as may be required in the cutting and removal of said timber.
