

O'BRIEN et al TO MAHAMA LUMBER COMPANY

KNOW ALL MEN BY THESE PRESENTS, Taht J.P.O'BRIEN and ANNIE L.O'BRIEN, his wife, and R.BLAISDELL and LILIAN L.BLAISDELL, his wife, of the County of Multnomah, in the State of Oregon, in consideration of Ninety and No/100 (\$90.00) Dollars, paid by MAHAMA LUMBER COMPANY, a corporation duly organized and existing under and by virtue of the laws of the State of Washington, do hereby remise, release and forever QUITCLAIM unto the said Mahama Lumber Company and to its successors and assigns all their right, title and interest in and to the following described parcel of real estate, situated in the County of Skamania in the State of Washington, to-wit:

All that part of Government Lot three (3) in Section Twenty-five (25), in Township Three (3) North, Range Nine (9) East, W.M. that lies West of a line that is parallel to and fifty (50) feet distant Easterly, masured at right angle, from the center line of the Drano Lake & Northern Railway and containing four and one half (4½) acres, more or less; said center line being more particularly described as follows:

Beginning at a point on the line between Sections 35 and 36, Township 3 North, Range 9 East, Willamette Meredian, designated Station 29+05.0 located South 1° 21' West 292.00 ft. from the corner common to Sections 25, 25, 35 and 36 Township 3 North, Range 9 East, Willamette meredian and running thence North 85° 51' East 695.00 ft. to Station 36+00, thence on a 3° 07' curve to the left 352.6 ft. to Station 39+52.6, thence on a 10° curve to the left 584.8 ft. to Station 45+37.4, thence North 16° 22' East 337.9 ft. to Station 48+75.3, thence on a 15° curve to the left 572.00 ft. to Station 54+47.3, thence North 69° 29' West 361.1 ft. to Station 58+08.4, thence on a 12° curve to the right 118.8 ft. to Station 59+27.2, thence North 55° 14' West intersecting the line between Section 25 and 26 at Station 69+25.0 South 1° 21' West 897.00 ft. from the quarter section corner common to Sections 25 and 26, Township 3 North, Range 9 East, Willamette Meredian.

The center line above described, for the purpose of continuity, embraces all of said center line in Sections 25 and 36, Township 3 North, Range 9 E., W.M., but this instrument conveys nothing outside of Lot 3 of said Section 25.

TO HAVE AND TO HOLD, the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining to the said Mahama Lumber Company, and to its successors and assigns forever.
