THIS INDENTURE WITNESSETH, THAT A. A. AUSPLUND PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF THREE THOUSAND DOLLARS (\$3,000) TO ME IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAS BARGAINED, SOLD AND CONVEYED AND BY THESE PRESENTS DOES BARGAIN, SELL AND CONVEY UNTO GLENN C. CORLIE PARTY OF THE SECOND PART, THE FOLLOWING DESCRIBED PREMISES, TO-WIT:

BEGINNING AT A POINT EIGHT (8) RODS WEST OF THE SOUTHEAST CORNER OF THE NORTHWEST QUARTER OF SECTION NINETEEN (19) TOWNSHIP THREE (3) NORTH, RANGE TEN (10) EAST OF WILLAMETTE MERIDIAN (RUNNING WESTERLY FORTY EIGHT RODS MORE OR LESS TO THE SOUTHEAST CORNER OF A TRACT HERETOFORE CONVEYED BY HUGH W. HAMLIN AND WIFE TO A. A. AUSPLUND, THENCE RUNNING NORTHERLY EIGHTEEN HUNDRED AND TWENTY FEET, MORE OR LESS, THENCE RUNNING EASTERLY TWO HUNDRED EIGHTEEN FEET, MORE OR LESS, TO THE RE-ENTRANCE ANGLE OF A TRACT OWNED BY G. C.
