We, the undersigned, being the Owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of Way 60 feet in width over and across the following described piece or parcel of land, to-wit:

Beginning at the intersection of the Baughman Donation Land Claim with the west boundary of Sec 1 Twp 2 North.Range 7 E.W.M. thence along the center line of the located line of permanent highway #2 to station 46 plus 41.5 or over all land owned by the grantors on the line of the located survey, rought of way being 30 feet on each side of center line, the grantors reserve the right to all timber on right of way and if timber is cut during the construction the length shall be cut so that it will measure in lengths of four feet lengths, without waste, The grantors also reserve the right to the present road when vacated, when permanent highway #2 is connected south with other county road, and waive all chaims for damage what ever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said road.
