

In consideration of One Dollar, the receipt whereof is hereby acknowledged, J.P. Grenia and E.M. Grenia his wife grant to NORTHWESTERN ELECTRIC COMPANY a perpetual right-of-way in and over the following described real property, situated in County of Skamania, State of Washington to-wit:

Lot Six (6) and the Southwest quarter of the Southeast quarter, also the Southeast quarter of the Southwest quarter of Section nineteen (19) Township 2 North Range 7 East of W.M. for the purpose of erecting, maintaining and operating thereon, two pole or tower lines for the transmission of electric current; together with the right to cut such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.

One line has been surveyed and staked across the land and begins in the East line of said Lot 6, 1966 feet Northerly from the intersection of the west line of the ^{of the} S.M. Hamilton Donation Land Claim line with the South line of said Section 19 measured along the Westerly line of Donation Land Claim Running thence in a straight line to a point in the west line of said S.E. $\frac{1}{4}$ of S.W. $\frac{1}{4}$ of said section (19) about 120 feet North of the center of the railroad track of the S.P. & S Ry. Co, which point is in the South side of the new road.

The second line shall be constructed parallel with the said surveyed line and not to exceed 50 feet from it and in a northerly direction, subject to State Road right-of-way.

DECLARATION OF HOMESTEAD

KNOW ALL MEN BY THESE PRESENTS, That I Robert H. Young, residing at Cooks, Skamania County State of Washington, is the head of a family consisting of my wife Mrs Bertha A. Young and One son, Kenneth R. Young;

That we are residing on, and claim the following described property as my Homestead, situate, lying, and being, in Cooks, Skamania County, State of Washington, described as follows to-wit:

Lots 16.17.18.19. and 20 in Block Six in the Townsite of Cooks, Skamania County, State of Washington, according to the duly recorded plat, on file in the Auditors Office of Skamania County state of Washington; also that parcel of land located in Cooks, Skamania County, state of Washington, described as follows to wit: Commencing at an iron pipe, one inch in diameter, at the intersection of the east side of Kerr street, in the town of Cooks Skamania County State of Washington, according to the official plat thereof, on file in the Office of the County auditor of Skamania County State of Washington, and the Section line, between section thirty four, and twenty seven, in township 3 North of Range 9 East of the Willamette Meridian, which point is seven hundred thirty three feet, west of the Southeast, Corner of the Southwest $\frac{1}{4}$ of the Southeast $\frac{1}{4}$ of Section 27 aforesaid; thence running from said point of beginning north
