DILLINGER TO HAZELTON

DEED TO EASEMENT FOR WATER PIPE LINE

IN CONSIDERATION OF ONE DOLLAR (\$1.00) to me in hand paid the receipt of which is hereby acknowledged, I, A. Dillinger, of The Dalles, Oregon owner thereof, grant to L.R. Hazelton of Underwood, Washington, an easement and right of way in and over the following described real property situated in the County of Skamania, State of Washington, to-wit:

The south half (S $\frac{1}{2}$ ) of the southwest quarter (SW $\frac{1}{4}$ ) of Section Sixteen (16) Township (3) North, Range Ten (10) E.W.M. containing 80 acres.

Said right of way to be for the purpose of constructing and maintaining a water pipe one inch in diameter or less said water pipe. to be placed at lease one foot below the surface of the ground and to follow the east line of said above described tract of land.
