

Two rights of way for electric power transmission lines across the following described land, to wit, Lot six (6) in section twenty-seven (27) and the northeast quarter (¼) of the southeast quarter (¼) of section twenty-eight (28) all in township three (3) north of range eight (8) east of the Willamette Meridian in Skamania County, State of Washington.

The first of above mentioned rights of way is described as follows, to wit: A right of way twelve feet wide for the purpose of building, maintaining and operating thereon an electric power transmission line, the center line of said right of way being located as follows, to wit: Commencing at a point in the east line of said lot six, ten feet north of the northern boundary of right of way of the Spokane, Portland & Seattle Railway; thence north 63 degrees west, 275 feet, thence north 67 degrees and 59 minutes west 321 feet, thence north 83 degrees west 375 feet; thence south 88 degrees west to a point in the west line of the northeast quarter of the southeast quarter of said section twenty-eight, 630 feet south of the northwest quarter of said northeast quarter of the southeast quarter of said section twenty-eight, as surveyed, staked and located across said land.

The second of the two rights of way above mentioned is described as follows, to wit: a right of way twelve feet wide for the purpose of building, maintaining and operating thereon an electric power transmission line, the center line of said right of way to be parallel with the center line of the right of way first above described and fifty feet distant therefrom in a northerly direction.

Together with the right to enter upon both of said rights of way as above described for the purpose of building, maintaining and operating the transmission lines to be located thereon as aforesaid, together with the right to cut such timber and brush as may interfere with or endanger either of said transmission lines out to a distance of 150 feet on either side of the center lines of the two rights of way above described. Conditioned, however, that the petitioner shall not have the right to fence or otherwise inclose either of said rights of way, or any part thereof; and reserving to claimants, their heirs, successors and assigns, the right in perpetuity to maintain and use a wagon road twenty-five (25) feet in width across the said rights of way at the points where the road now used by claimants to cross the right of way of the Spokane, Portland & Seattle Railway crosses the rights of way herein appropriated.
