KNOW ALL MEN BY THESE PRESENTS, THAT CORDELIA EHMAN THE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN, (\$10.00) TEN DOLLARS, OF THE UNITED STATES OF AMERICA, TO ME IN HAND PAID BY ED W. MILLER. THE PARTY OF THE SECOND PART, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD, ASSIGNED, TRANSFERRED AND SET OVER, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL, ASSIGN, TRANSFER AND SET OVER, UNTO THE SAID PARTY OF THE SECOND PART, A CERTAIN INDENTURE OF MORTGAGE, BEARING DATE THE 2ND DAY OF APRIL 1915.
