NORTHWESTERN ELECTRIC COMPANY, a corporation, Petitioner,

DECREE OF APPROPRIATION.

ALDEN KINCMAN and SMMA KINGMAN, his wife, and BANK OF STEVENSON, a corporation, Claimants.

The claimants, Alden Kingman and Emma Kingman, his wife, and Bank of Stevenson, a corporation, having admitted in open court the right of said petitioner, Northwestern Electric Company, to condemn the rights of way and apputtenences hereinafter described, and the court having so found;

And a jury, duly impaneled, having rendered their verdict that the amount of the compensation to be paid to said claimants by said petitioner, Korthwestern Electric Company, for the taking by the petitioner of said rights of way and appurtenances across the east half of the southeast quarter of section twenty-seven (27) township three (3) north of range nine(9) east of the Willamette Meridian, in Skamania County, State of Washington, is Seven Hundred (700) Dollars, and the amount of the compensation to be paid to said claimants by said petitioner, Northwestern Electric Company, for the taking by the petitioner of said rights of way and appurtenances across Lots four (4) and five (5) in section twenty-six (26), said township and range, is five hundred (500) Dollars;

And the court having rendered judgment in favor of the claimants for said amounts, together with their costs herein taxed at Thirty six and 55/100 (36.55) Dollars;

And said petitioner having paid said compensation to said claimants and the costs of these proceedings by depositing the amount of said compensation and of said costs with the clerk of the above entitled court to be paid out under the direction of said court, or judge thereof.

It is now, Considered, Ordered and Decreed that the petitioner, Northwestern Electric Company, appropriate the following described rights of way and appurtenances, to wit:

Two rights of way for electric power transmission lines across the rollowing described land, to wit: the east half (1-2) of the southeast quarter (1-4) of section twenty-seven (27) and lots four (4) and five (5) in section twenty-six (26), all in township three (3) north of range nine (9) east of the Willamette Meridian. In Skamania County, State of Washington.

The first of the above mentioned rights of way is described as follows, to wit: a right of way twelve (12) feet wide to build, maintain and operate an electric power transmission line thereon, the center line of said right of way being located as follows, to wit,

commencing at a point in the east line of Lot Four (4) in said section twenty-six (26) eighty (80) feet north of the southeast corner of said Lot four (4), thence south, eighty-three (83) degrees and forty-five (45) minutes west, seven hundred and sixty (760) feet, thence south, seventy-eight (78) degrees and forty-five (45) minutes west, two hundred and seventy-eight feet, thence south seventy-three (73) degrees and forty-five minutes west, six hundred and forty (640) feet, thence south, seventy degrees and forty-five minutes west, four hundred and fifty (450) feet, thence south sixty-eight degrees and forty-four (44) minutes west, to a point in the west line of the said east half of the southeast quarter (1-4) of said section twenty-seven (27), six hundred and fifty (650) feet north of the southwest corner of said east half (1-2) of the southeast quarter (1-4) of said section twenty-seven (27) as surveyed, staked out and located across said land.

The second of the two rights of way above mentioned is described as follows, to wit; a right of way twelve feet wide to build, maintain and operate an electric power transmission line thereon, the center line of said right of way to be parallel with the center line of the right of way first above described and fifty (50) feet distant therefrom in a northerly
