A tract of land described as beginning at a point 60 feet North of the Northwest corner of Lot 7 in Block 2 of Rose Lawn Addition to the Town of Stevenson, Wash. at the head of Roosevelt Street in Sec. 36 of Tp. 3 North, of Range 7 E.W.M. as platted and on file with the auditor of Skamania County, Wash. thence North 100 feet, thence Westerly paralleling the Rock Creek Road or Hot Springs Alameda 100 feet, thence South 100 Feet to the said road or alameda. thence along its Northerly line Easterly 100 feet to the place of beginning,
