

In Consideration of the sum of \$100.00 (One hundred dollars) the receipt whereof is hereby confessed, we hereby agree to convey to the Town of Stevenson, a Municipal corporation, the following real estate in the Town of Stevenson, Skamania County, Washington, to-wit:

Commencing at a point where the center line of Second Street, as surveyed and platted by the Town Engineer, intersects the west line of the Shepard Donation Land Claim, thence south 30 feet to the south line of said Second Street, thence following the south line of Second Street east to point where said south line angles northerly; thence north 55 deg. along the south line of said Second street to the west side of Seymore Street, thence northerly along Seymore Street to the point of beginning. The said property being that portion of land necessary to complete Second Street to the full width of sixty feet, as surveyed by the City Engineer.
