THE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF \$200.00 TWO HUNDRED DOLLARS, OF THE UNITED STATES OF AMERICA, TO ME IN HAND PAID BY T. C. DUNCAN, THE PARTY OF THE SECOND PART, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, HAS GRANTED, BARGAINED, SOLD, ASSIGNED, TRANSFERRED AND SET OVER, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL, ASSIGN, TRANSFER AND SET OVER, UNTO THE SAID PARTY OF THE SECOND PART, A CERTAIN INDENTURE OF MORTGAGE, BEARING DATE THE 2ND DAY OF APRIL, 1915, A.D.
