clerk of the above entitled court, to be paid out under the direction of said court, or judge thereof.

IT IS NOW, CONSIDERED, CRDERED AND DECREED that the petitioner, Northwestern Electric Company, appropriate the following described rights of way and appurtenances, to wit:

Two rights of way for electric power transmission lines across the following described property, to wit: Beginning 1850 feet east of the quarter corner of section 11, T.2 N.R.7

IN W. M. running thence 850 feet east to the right of way of the Spokane Portland & Seattle Railway; thence following the right of way line of said S.P. & S. Ry. to a point 1000 feet north of the center line through Section 11 of said township and range; thence west 1130 feet; thence south 1000 feet to the place of beginning;

Also the following described tract: commencing 997 feet west of the intersection of the north line of above described tract of land with the north line of the Spokane, Portland & Seattle Railway right of way; thence north 43° west 400 feet to the county road, as now established and platted; thence south 69° 53' west 106 feet along said county road to Bowles Creek; thence south 43° east, following said creek 350 feet more or less to the east and west line of tract; thence east 135 feet more or less to the place of beginning: both tracts of land hereby described together aggregating 22 acres, more or less.

Also beginning at a point where the northeast corner of that tract of land above described joins the westerly right of way line of the Spokane, Portland & Seattle Railway; running thence west along the north line of said above described tract belonging to E.P.Ash, 995 feet; thence north 43° west 275 feet more or less to a point 200 feet north or the south line projected and above described; thence east, parallel with the south line as above described; and 200 feet distant therefrom, 1230 feet more or less, to westerly right of way line of S.P. & S. Ry.; thence southerly allong said right of way to beginning.

The first of the above mentioned rights of way id described as follows, to wit: A right of way 12 feet wide for the purpose of building, maintaining and operating thereon an electric power transmission line, the center line of said right of way being located as follows, to wit: Commencing at a point in the north boundary of said above described land, considering it together as one single tract 841.90 feet west of the northeast cornermof said land, considering it as one single tract; thence south 60 degrees 44 minutes west 450 feet in a straight line to the west boundary of said land, considering it as one single tract, as surveyed, staked out and located across said land, and as shown upon a plat marked "Exhibit A" and attached hereto and made a part hereof.

The second of the two rights of way above mentioned is described as follows, to wit:

A right of way twelve feet wide for the purpose of building, maintaining and operating thereon an electric power transmission line, the center line of said right of way to be parallel with the center line of the right of way first above described and fifty feet distant therefrom in a northerly direction, as shown upon the said "Exhibit A".

Together with the right to enter upon both of said rights of way as above described for the purpose of building, maintaining and operating the transmission lines to be located thereon as aforesaid; and the right to cut such timber and brush as may interfere with or endanger either of said transmission lines, out to a distance of 150 feet on either side of the center lines of the two rights of way above described; conditioned, however, that the petitioner shall not have the right to fence or otherwise inclose either of said two rights of way, or any parts thereof, and shall not place its poles or towers carrying said transmission lines at a less distance, on either of said rights of way, then 200 feet from each other; so that on each of said rights of way there shall be clear and unobstructed places between all poles or towers thereon of at least 200 feet, which spaces shall be left clear and unobstructed for the passage across said rights of way of the claimants, their heirs, executors, successors and
