Kollock-Crooker to be given to Annie Prust if Florence Crooker thinks it wisest and best". and substitute therefor the following:

Fifth: I give and bequeath the sum of One Hundred Dollars (\$100) to Annie Prust.

I give and bequeath the Six Hundred Dollars (\$600) resulting from the foregoing changes and reductions of the bequests under sub-divisions Second and Fifth, as follows:

Sub-division Twenty-eighth.- I give and bequeath to Reverend George Gray, conducting the "Forward Movement" in the čity of Chigago, Illinois, Two Hundred and Fifty Dollars (\$250) to be held in trust by him and his successors in the work, and used to defray the expenses of outings for poor children.

Sub-division Twenty-ninth.- I give and bequeath One Hundred and Fifty Dollars (\$150) to Reverend Lyman Ward of Camp Hill School, of Camp Hill, Alabama, or his successor to be used to pay the expenses of educating poor white youth and children.

Sub-division Thirty .- I give and bequeath to Mrs. Laura R. Bacon residing at No.6039 Kimbark Avenue, Chicago, Illinois, the sum of One Hundred Dollars (\$100).

Sub-division Thirty-one.- I give and bequeath to Dr. George C. Kollock, of the City of Madison, Wisconsin, the sum of One Hundred Dollars (\$100.00) in trust, the income of which I direct shall be used in defraying the expense of caring for the cemetery lot standing in his name on the records of the Forest Hill Cemetery, in the city of Madison, Wisconsin, and direct that the same shall be used for the care of the graves thereon.
