That said Wiblwas not changed, altered, amended or any of the clauses revoked by the memoranda, lines and erasures made thereon; that the death of Dr. Evelyn Kollock before the death of testatrix revokes Clause Second of said Will; that Eliza Sanford, mentioned in Clause Nine, predeceased the testatrix and her legacy goes to her children Etta Sanford, Mrs. Marietta Forbes and Fmank Sanford in equal shares; that the testatrix left no money on deposit in the Savings Bank at Beverly, Massachusetts, and no real estate within the jurisdiction of this Court as provided in Clause Twenty-sixth or in the State of Wisconsin; that Ann C.Little mentioned in Clause Twenty-fourth predeceased the testatrix and that her issue are entitled to her legacy; that her issue consists of eight grandchildren as follows: Harry L. Starker, Maude M. Starker, Mrs. Charles Bliss, Geo.L.Clark, and four children of Chas.M.Little, deceased, residing with their mother at Hemlock Michigan, ages and names unknown.

That said administrator is chargeable with the sum of six thousand three hundred fifty-four dollars and sixty cents (\$6,354.60).

That said administrator is to be credited with the sum of one thousand one hundred fifty-nine dollars and two cents (\$1,159.02).

That the inheritance tax in said estate has been determined and paid and the receipt of the Treasurer of Dane County filed in this Court.

That all claims filed and allowed against said estate have been paid.

That the said George C. Kollock, Florence K. Crooker and W.M.Kollock are entitled to the residue of the said estate after the payment of the legacies in accordance with the foregoing findings.

WHEREFORE IT IS ORDERED AND ADJUDGED, That the accounts of the said administrator as stated as aforesaid be, and the same are hereby allowed.

That Clause Second of said Will as modified by the Codicil thereto is hereby revoked.

That Clause Twenty-sixth of said Will is hereby revoked
