NORTHERN PACIFIC RAILWAY COMPANY.

THIS DEED made the tenth day of October in the year of our Lord one thousand nine hundred and thirteen, by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation of the State of Wisconsin, grantor, to JOHN C.JACOBSEN, of Portland in the County of Multnomah and State of Oregon, grantee,

WITNESSETH: The grantor in consideration of the sum of Nineteen hundred sixty and no/100 (\$1960.00) Dollars unto it paid, the receipt whereof is acknowledged, remises; releases, and quit claim unto the grantee his heirs and assigns, all its right, title and interest in and to the following described tract of land, situate in the County of Skamania and State of Washington, to-wit:

East half of northeast quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$) of Section seven (7), southwest quarter of northwest quarter (SW $\frac{1}{4}$ of NW $\frac{1}{4}$) and northwest quarter of southwest quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section eight (8), in Township three (3) North, of Range ten (10) East of the Willamette Meridian, containing, according to the United States Government Survey, one hundred sixty (160) acres more or less; subject, as reserved in the patent from the United States, to a right of way thereon for ditches or canals constructed by authority of the United States.
