THIS DEED made the tenth day of October in the year of our Lord one thousand nine hundred and thirteen, by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation of the State of Wisconsin, grantor, to J.K.LUMBER COMPANY, a corporation of the State of Washington, of Portland in the County of Multnomah and State of Oregon, grantee, WITNESSETH:

The grantor, in consideration of the sum of Four hundred ninety and no/100 (\$490.00) Dollars unto it paid, the receipt whereof is hereby acknowledged, remises, releases and quit claims unto the grantee, its successors and assigns, all its right, title and interest in and to the following described tract of land situate in the County of Skamania and State of Washington, to-wit:

Southeast quarter of southwest quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section six (6), in Township two (2) North of Range seven (7) East of the Willamette Meridian, containing, according to the United States Government Survey, forty (40) acres, more or less; subject, as reserved in the patent from the United States, to a right of way thereon for ditches or canals constructed by authority of the United States.
