

KNOW ALL MEN That: WHEREAS, the Oregon-Washington Timber Company, a corporation under the laws of the State of Oregon, has heretofore acquired a large amount of real property in Skamania County, State of Washington, and now holds and owns the same; and

WHEREAS, the Oregon and Washington Timber Company, a corporation under the laws of the State of Washington, has been, during the time when said properties were acquired, doing business in said State under its corporate name, and the similarity of corporate names of said corporations is likely to lead to confusion and doubts as to the ownership of said properties; and the said Oregon and Washington Timber Company is about to change its corporate name for the purpose of avoiding such confusion, and desires now to remove any cloud which might exist upon the title of the Oregon-Washington Timber Company to its said property because of such similarity of names:

NOW THEREFORE THIS WITNESSETH, that in consideration of the premises and of One Dollar to it in hand paid, the said Oregon and Washington Timber Company, a corporation under the laws of the State of Washington, does hereby remise, release and forever quitclaim unto the said Oregon-Washington Timber Company, a corporation under the laws of the State of Oregon, the following described property situated in Skamania County, State of Washington: to-wit:--

The East half of the Northeast quarter of Section twenty-five; the North half of the North half of Section twenty-four; the East half of the Northeast quarter and the North half of the Southeast quarter of Section twenty-three; the East half and the East half of the West half and the Southwest quarter of the Northwest quarter, and the Northwest quarter of the Southwest quarter of Section Fourteen; the whole of Section thirteen; the East half of Section eleven; the Southeast quarter and the Southwest quarter of the Northeast quarter, and the Northeast quarter of the Northwest quarter, and the West half of the Northwest quarter, and the Northwest quarter of the Southwest quarter, and the South half of the Southwest quarter of Section Twelve; the Southeast quarter of Section Two; the whole of Section one; ~~XXXXXX~~ all in Township Two North, Range Five East, Willamette Meridian.

The Northwest quarter of Section thirty; the Southwest quarter, and the North half of the North half of Section Nineteen; the whole of Section Eighteen; the Southeast quarter of the Southeast quarter, and the Southwest quarter, and the Southwest quarter of the Northwest quarter of Section Seven; the Northwest quarter of Section Eight; the Southwest quarter of the Southeast quarter, and the Southwest quarter and the Southeast Quarter of the Northwest quarter, and the West half of the Northwest quarter of Section six; all in Township Two North, Range Six East, Willamette Meridian.

The North half of the Northeast quarter, the South half of the Southeast quarter of Section Thirty-four; the whole of Section thirty-five; the South half and the Northeast quarter of Section Thirty-six; the South half of Section Twenty-five; the Southwest quarter, and the Southwest quarter of the Southeast quarter, and the Southwest quarter of the Northwest quarter of Section twenty-six; the Northwest quarter of Section twenty-four; the Southwest quarter of the Southeast quarter of Section thirteen; all in Township Three North, Range Five East, Willamette Meridian.

The whole of Section Thirty-one; the whole of Section thirty-two; the whole of Section twenty-eight; the Northwest quarter of Section Twenty-nine; the Southwest quarter of Section Thirty; the Southwest quarter of Section Twenty; the Southeast quarter and the West half of Section nineteen; the whole of Section eighteen; the Southwest quarter of Section Seventeen; the Southwest quarter of Section Eight; all in Township Three North, Range Six East, Willamette Meridian.
