THOMAS TO NORTHWESTERN ELECTRIC COMPANY.

KNOW ALL MEN BY THESE PRESENTS, That Joe Thomas, for and in consideration of the sum of One Hundred (\$100) Dollars, receipt whereof is hereby acknowledged, grants, bargains, sells and conveys, and by these presents does hereby grant, bargain, sell and convey unto the NORTHWESTERN ELECTRIC COMPANY, its successors and assigns, a perpetual right of way to build, maintain and operate two (2) pole or tower lines for the transmission of electricity across the following described property, to-wit: Lots two (2), three (3), and seven (7) of Section twenty-six (26), Township three (3) North, Range nine (9) East of the Willamette Meridian, Skamania County, Washington. Said rights of way are more specifically described as follows:
