

A right of way ten (10) feet in width, the center longitudinal line of which commences at a point on the western boundary of Lot seven (7), Section twenty-six (26), Township three (3) North, Range ten (10) East of the Willamette Meridian, eighty (80) feet north of the southwest corner of said Lot seven (7); thence running north across said Lots Seven (7), three (3), and two (2) eighty-three (83) degrees and forty-five (45) minutes east, a distance of twenty-three hundred and seventy (2370) feet to a point; thence running north eighty-seven (87) degrees and twenty-one (21) minutes east to the eastern boundary of said Lot two (2) of said Section twenty-six (26).

a second right of way ten (10) feet in width, the center longitudinal line of which commences at a point on the western boundary of Lot seven (7), Section twenty-six (26), Township three (3) North, Range ten (10) East of the Willamette Meridian; One Hundred thirty (130) feet north of the southwest corner of said Lot seven (7) and fifty (50) feet north of the aforementioned right of way; thence running north across said lots seven (7), three (3), and two (2), parallel to and with the first mentioned right of way, eighty-three (83) degrees and forty-five (45) minutes east, a distance of twenty-three hundred seventy (2370) feet to a point; thence running north eighty-seven (87) degrees and twenty-one (21) minutes east to the eastern boundary of said Lot two (2) of said Section twenty-six (26);

Together with the right to cut such trees and brush as may interfere with or endanger said transmission lines, whether such trees and brush are upon the ten (10) foot rights of way herein granted or outside of the same.

Said rights of way are merely easements and carry with them no title to the lands.
