PORTLAND, COUNTY OF MULTNOMAH, STATE OF OREGON, AND RUNNING THENCE IN A GENERAL EASTERLY DIRECTION THROUGH THE TOWNS OF GRESHAM, PLEASANT HOME AND COTTRELL, IN SAID MULTNOMAH COUNTY, AND THE TOWN OF MABERY, IN CLACKAMAS COUNTY, STATE OF OREGON, TO ITS EASTERLY TERMINUS AT THE TOWN OF BULL RUN IN THE SAID COUNTY OF CLACKAMAS;

- (B) ALSO THE HYDRO-ELECTRIC DEWELOPMENT, COMPRISING THE DAM, RESERVOIR AND POWER HOUSE LOCATED AT BULL RUN IN THE COUNTY OF CLACKAMAS, AND THE CANALS, DITCHES, FLUMES, TUNNELS, DAMS, BRIDGES, WATER-WHEELS, BREAKWATERS, SLUCES, AND BASINS, CRIBS AND BULKHEADS, FIXTURES, MACHINERY, TOOLS AND APPLIANCES AND RIGHTS. OF WAY AND CONTRACT RIGHTS, WATER RIGHTS, RIPARIAN RIGHTS, AND RIGHTS OF APPROPRIATION AND DIVERSION CONNECTED WITH SAID HYDRO-ELECTRIC DEVELOPMENT;
- (c) ALSO THE STEAM POWER PLANT LOCATED AT PORTSMOUTH IN THE CITY OF PORTLAND, AND THE ELECTRIC SUB-STATIONS AT PORTLAND AND AT VANCOUVER IN THE STATE OF WASHINGTON;
- (D) ALSO THE ELECTRIC, LIGHT AND POWER LINES RUNNING FROM AND CONNECTING SAID POWER PLANTS AND SUB-STATIONS, AND THE WIRES AND DISTRIBUTING SASTEMS IN THE CITIES OF PORTLAND AND VANCOUVER, AND IN THE COUNTIES OF MULTNOMAH AND CLACKAMAS IN THE STATE OF OREGON, AND IN THE COUNTY OF CLARKE IN THE STATE OF WASHINGTON;
- (E) ALSO ALL CARS, TRACKS, ELECTRICAL AND OTHER EQUIPMENT, BUILDINGS, STRUCTURES AND IMPROVEMENTS, AND ALL MACHINERY, TOOLS, FIXTURES AND APPARATUS, AND ALL BRIDGES, TRESTLES, ELEVATED ROADWAYS, POLES, LINES OF WIRE AND ALL RIGHTS OF WAY, LEASES, LEASEHOLD INTERESTS, AND CONTRACT: RIGHTS USED IN CONNECTION WITH THE SAID RAILROADS, RAILWAYS, WATER POWER, STEAM AND ELECTRIC PLANTS, LIGHT AND POWER LINES AND PROPERTIES;
- (F) ALSO ALL THE RIGHTS, PRIVILEGES, FRANCHISES AND IMMUNITIES GRANTED TO AND CONFERRED UPON THE MOUNT HOOD RAILWAY AND POWER COMPANY BY THE FOLLOWING ORDINANCES AND GRANTS:

ORDINANCE NO. 20 OF THE TOWN OF LINNTON, PASSED BY THE TOWN COUNCIL, MAY 24, 1911, AND APPROVED BY THE MAYOR, MAY 31ST, 1911;

ORDINANCE NO. 33 OF THE TOWN OF LINNTON, PASSED BY THE TOWN COUNCIL ON JUNE 11, 1912, AND APPROVED BY THE MAYOR ON THE SAME DATE;

ORDINGNCE No. 57 of the Town of Gresham, passed by the Town Councul, October 30, 1911, and approved by the Mayor on the same date.
