Hooker and Myrtle Hooker, the undersigned, being the incumbrancers of the property herein described, do in consideration of the sum of Sixty-two and 50/100 (\$62.50) Dollars, the receipt whereof is hereby acknowledged hereby consent that said right of way be as now located on and over said premises, excepting the removal of two posts of said power line over said right of way so as not to interfere with the building of barn and other out buildings of the said parties of the first part, and forever relinquish a perpetual right of way to said Skamania Light and Power Company over, across and above said premises, to-wit:

Lots One (1) and Two (2) in Hamilton's Tracts in Lot 12 in Sec. 36 Tp. 3 North Range 7½ East Willamette Meridian.

And waive all claims for damages of whatever kind which may be occasioned to said land or any portion of same by maintaining, repairing or examining said power line, giving and granting to said Skamania Light and Power Company the said easement with full power and authority to examine, survey, lay out and establish and maintaining said power line.
