Incorporated, the following described lands and property, situated in the County of Skamania, State of Washington, to-wit:

(1) Beginning at a point One Hundred Sixty Five Feet (165), South and Thirty (30) feet West of the Northeast Corner of the Northwest Quarter of the Northeast Quarter of Section Twenty-nine (29), in Township Three (3), North of Range Eight (8), East of the Willamette Meridian, running thence West One Hundred (100) feet, thence South Sixty (60) feet, thence East One (100) Hundred Feet, Thence North Sixty (60) feet to the place of beginning.

(2) Beginning at a point Thirty (30) feet East and One Hundred Feet North of the Southwest corner of the Southeast Quarter of the Southeast Quarter of Section Twenty (20), in Township Three, North of Range Eight (8), East of the Willamette Meridian, running thence East One (100) Hundred Feet, thence North Fifty (50) feet, thence West One Hundred (100) feet, thence South Fifty Feet to the place of beginning.
