We, the undersigned, being the Owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60.00 feet in width over and across the following described piece or parcel of land, to-wit: Beginning at a point 812.2 feet West and 104. feet South of the 1 section corner on the north boundary of section one twp 2.north range 4. east W.M. this point being station oo plus oo and the point of beginning sixty foot strip of rights of way thence along the center line of the road as now on file in the county engineers office to station 13 21 .5 same being the west line of the above named owners, thence beginning at the southwest corner of lot #8 section 1. twp 2. north range 7. east W.M. thence to a point 15.00 feet, west of station 30 00;5 thence on a straight line to station 31 63.5 said description from southwest corner of lot #8 as named above is to be the east boundary of a sixty foot strip of rights of way. This waiver is given with the following provisos that the road now used as a county road through the owner's place be vacated and abandoned on or before two years from date, also all merchantable timber be reserved by the grantors, and all noxious weeks shall be destroyed by the county during such time as this is used as a public highway.

The east boundary of the above named right of way from the southwest corner of Lot #8 Sec. 1 T.2 N.R.7 E. W.M. is 12 feet east of section line. and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.
