

SECTION TO A POINT IN THE NORTHERLY SIDE LINE OF SAID TRACT TWENTY-ONE (21); SAID POINT BEING LOCATED SEVENTY (70) FEET EASTERLY OF THE NORTHWEST CORNER OF THE SAID TRACT TWENTY-ONE (21); THENCE WEST ALONG THE NORTHERLY SIDE LINE OF SAID TRACT TWENTY-ONE (21), SEVENTY (70) FEET TO THE NORTHWEST CORNER OF THE SAID TRACT TWENTY-ONE (21); THENCE IN A SOUTHERLY DIRECTION TRACING THE WESTERLY SIDE LINE OF SAID TRACT TWENTY-ONE (21) TO THE SOUTHWEST CORNER OF SAID TRACT TWENTY-ONE (21), THE PLACE OF BEGINNING. BEING A PARCEL OF LAND SEVENTY (70) FEET IN WIDTH AND ONE HUNDRED SIXTEEN (116) FEET, MORE OR LESS, IN LENGTH CONTAINING EIGHTEEN HUNDREDTHS (.18) OF AN ACRE MORE OR LESS.

70. ALSO A PORTION OF TRACT NUMBERED TWENTY (20) IN SAID SUPPLEMENTAL PLAT OF BORING JUNCTION, WHICH PORTION IS PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF SAID TRACT TWENTY (20); THENCE EAST TRACING THE SOUTHERLY SIDE LINE OF SAID TRACT TWENTY (20), THREE AND FIVE-TENTHS (3.5) FEET TO A POINT; THENCE IN A NORTHERLY DIRECTION ONE HUNDRED NINETEEN AND SIX-TENTHS (119.6) FEET TO A POINT IN THE WESTERLY SIDE LINE OF SAID TRACT TWENTY (20), THENCE IN A SOUTHERLY DIRECTION TRACING THE WESTERLY SIDE LINE OF SAID TRACT TWENTY (20), TO THE SOUTHWEST CORNER OF THE SAID TRACT TWENTY (20), THE PLACE OF BEGINNING.

71. ALSO ALL THAT PORTION OF THE ARCHIBALD MCKINLEY DONATION LAND CLAIM IN TOWNSHIP TWO (2), SOUTH OF RANGE TWO (2) EAST OF THE WILLAMETTE MERIDIAN INCLUDED IN THAT PORTION OF WHAT IS KNOWN AND PLATTED AS BLOCK TWENTY-ONE (21) OF THE TOWN OF CANEMAH DESCRIBED AS FOLLOWS:

ALL THAT PORTION OF SAID BLOCK TWENTY-ONE (21) WHICH LIES NORTH OF THE, SOUTH LINE OF THE SAID ARCHIBALD MCKINLEY DONATION LAND CLAIM AND EAST OF A LINE DESCRIBED AS BEGINNING AT A POINT IN THE LINE BETWEEN THE DONATION LAND CLAIM OF ARCHIBALD MCKINLEY AND ABSOLOM F. HEDGES, WHICH POINT IS SOUTH FORTY-FOUR DEGREES (44°) TWENTY-NINE MINUTES (29') EAST AND FOUR AND 06-100 (4.06) FEET DISTANT FROM THE CENTER LINE OF THE RAILWAY TRACK OF THE MORTGAGOR COMPANY, AS THE SAME IS NOW LAID ON THE GROUND; THENCE NORTH THIRTY-FIVE DEGREES (35°) FORTY-NINE MINUTES (49') EAST PARALLEL WITH AND FOUR (4) FEET DISTANT FROM THE CENTER LINE OF THE SAID RAILWAY TRACK, ONE HUNDRED AND TWENTY-FIVE (125) FEET MORE OR LESS TO AN INTERSECTION WITH THE NORTHERLY SIDE LINE OF SAID BLOCK TWENTY-ONE (21).

72. ALSO ALL OF LOTS <sup>TEN</sup> (10), ELEVEN (11) AND TWELVE (12) OF BLOCK TWENTY-ONE (21) AND LOTS TEN (10), ELEVEN (11) AND TWELVE (12) OF BLOCK TWENTY-THREE (23) OF LINN CITY.

73. ALSO THE WEST HALF OF THE WEST HALF OF SECTION THIRTY-TWO (32) AND WEST HALF OF SOUTHEAST QUARTER OF SECTION THIRTY (30) ALL IN TOWNSHIP SIX (6), SOUTH OF RANGE THREE (3) EAST OF WILLAMETTE MERIDIAN.

74. ALSO THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION EIGHTEEN (18) TOWNSHIP SIX (6) SOUTH OF RANGE THREE (3) EAST OF WILLAMETTE MERIDIAN.

75. ALSO ALL OF THE NORTHWEST QUARTER ( $\frac{1}{4}$ ) OF SECTION EIGHTEEN (18) TOWNSHIP FOUR (4), SOUTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN.

76. ALSO THE SOUTH HALF OF THE SOUTHEAST QUARTER OF SECTION NUMBER ELEVEN (11) AND THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION NUMBER TWELVE (12) AND THE SOUTHWEST QUARTER OF SECTION NUMBER TWELVE (12), ALL IN TOWNSHIP FOUR (4) SOUTH OF RANGE FOUR (4) EAST OF THE WILLAMETTE MERIDIAN, CONTAINING TWO HUNDRED EIGHTY (280) ACRES.
