

FEET TO PLACE OF BEGINNING; CONTAINING ONE AND TWENTY-NINE HUNDREDTHS (1.29) ACRES, MORE OR LESS.

81. ALSO A TRACT OF LAND DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER ($NW\frac{1}{4}$ OF $SE\frac{1}{4}$) OF SECTION FOURTEEN (14), TOWNSHIP TWO (2) SOUTH, RANGE FIVE (5) EAST OF WILLAMETTE MERIDIAN; THENCE RUNNING SOUTH ONE HUNDRED AND FIFTY (150) FEET, THENCE WEST FOUR HUNDRED AND FIFTY (450) FEET, THENCE NORTH ONE HUNDRED AND FIFTY (150) FEET, THENCE EAST FOUR HUNDRED AND FIFTY (450) FEET TO THE POINT OF BEGINNING.
