THIS INDENTURE, Made this 14th day of November 1918, Between J. W. Bethea and Hazel E. Bethea, his wife parties of the first part, and Myrtle S. Attwell party of the second part, Witnesseth: That the said parties of the first part for and in consideration of the sum of ---Thirteen thousand and no/100 (\$13000.00) Dollars lawful money of the United States to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do, by these presents, grant, bargain, sell, convey and warrant unto the said party of the second part, and to her heirs and assigns, the following described tracts or parcels of land lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to-wit:

Beginning at a point one and 27/100 chains (1.27 ch) west of the Northeast corner of section twenty-five (25) in township two (2) north of Range six (6) east of the Willamette Meridian; running thence east seventy-seven (77) chains; thence south twenty-two (22) degrees east, eleven and 40/100 (11.40) chains to the north Bank of Hamilton Creek; thence with the meanders of said creek and the Columbia River down stream to a point due south of the place of beginning; thence due north fifty-seven and 40/100 (57.40) chains to the place of beginning.
