Therkelsen (husband and wife) County of Multnomah in the State of Oregon, being of lawful age, in consideration of One Dollar and other considerations to them paid by Earl Moore of the same place in the State of Oregon, do hereby grant, bargain, sell and convey unto said Earl Moore his heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington.

All the West Half ( $W\frac{1}{2}$ ) of the South East quarter ( $SE\frac{1}{4}$ ) of the South East quarter ( $SE\frac{1}{4}$ ) of Section Numbered Five (5) in Township Two (2) North, Range Seven (7) East of Willamette Meridian, containing 20 acres more or less.

TO HAVE AND TO HOLD, the above granted premises with all the rights, easements and appurtenances thereto belonging unto the said Earl Moore his heirs and assigns forever. And the said grantors do covenant to and with the said grantee his heirs and assigns that we are lawfully seized in fee of the above granted premises; that they are free from all encumbrances, except one certain Mortgage for \$100.00 covering the S.E.  $\frac{1}{4}$  of the S.E.  $\frac{1}{4}$  of said Section 5 Twp. 2 North Range 7 east of W.M. \$50.00 of which said grantee assumes and that we will and our heirs, executors and administrators shall warrant and defend the above granted premises, to the said grantee his heirs and assigns forever against the lawful claims and demands of all persons except as above stated.
